#### **Educational aims of the course**

The Foundation Degree (FdSc) in Criminology aims to provide students with a comprehensive understanding of criminology - a discipline which draws upon a range of other disciplines including law, psychology and sociology; equipping them with essential knowledge, skills, and experience for further study or entry-level roles in related professional fields. The course is designed to:

- Introduce students to core criminological principles including criminological theory and criminal justice.
- Establish a foundational understanding of the links between the disciplines making up the field of criminology and criminal justice.
- Instil an awareness of the intersection between criminology and criminal justice and issues relating to diversity, social justice and human rights.
- Develop an understanding of real-life applications of theory to problems of crime causation and crime solutions, and the subsequent development of new policies, practices and legislation in a comparative international context.
- Provide students with the opportunity to develop key academic skills, enabling critical thinking and the ability to undertake independent research.
- Enhance communication skills by training students to present their ideas effectively through visual, verbal, and written formats.
- Support independent learning and problem-solving abilities, and provide the opportunity to develop transferable skills required for future professional success.
